**JOINING OUR BOARD**

Please call the Membership Department to book an appointment for an orientation session and to be set up for access to the OMDREB MLS® System. The Membership Application must be submitted prior to orientation session.

All new Members must attend a hands-on Matrix Training Session. Members will be given four (4) months time period in which to take this course. Failure to do so will result in a \$100 fine.

**Authenticators**

Every new Member joining the Board will purchase a security authenticator to log on to Matrix which generates a password every time you need to log on to the MLS® System. The authenticator is provided for the sole and exclusive use of the subscriber and may not be shared with or used by any other person. Failure to comply with this provision will result in the matter being referred to the Professional Standards Committee for possible disciplinary action against the offending subscriber, which may include a maximum fine of \$10,000 and loss of subscriber privileges.

There is a fee of \$50.00 for an authenticator. To re-assign SAFEMLS® device to another applicant there is a \$25.00 transfer fee.
