

Scholarship 2017 Application Form

Applicants can produce their submission in the following formats (essay topics provided below):

- a. A written essay (1,000 to 1,500 words, typed, double spaced and bound).
- b. A video, no longer than five (5) minutes in length (mpeg, wave, Windows Media Player or YouTube link).

Four (4) scholarships will be awarded in 2017. Each winner will receive \$2,500.

Eligibility Requirements

- 1) Applicants may choose one of the following essay topics:
 - 1) Why is there a stigma around hunger, specifically in a first-world society? What can the Halton community do to combat this stigma?
 - 2) Research essay Please write a minimum 1,000 word essay about one of the following charity organizations – Food4Kids and Halton Food For Thought – and answer the following:
 - a. What does the organization do and what communities do they serve? (INTRO)
 - b. What background information is necessary to understand the problem the organization is trying to solve?
 - c. What solutions can be put forth to solve this issue?
 - d. Based on your research, what are some suggestions you have for the organization to expand and increase its reach and impact in the community?
 - 3) You're offered a position to work in the marketing department at Food4Kids or Halton Food For Thought. Please create at 2- or 3-minute video campaign, which aims to educate families on how to meet their daily needs via budgeting, assistance with food plans and nutrition, and providing guidance on other related areas.
 - 4) What is the impact of malnutrition on academic success? How can the educational system be enhanced to help individuals break this life cycle?
 - 5) Create a proposal/letter to potential donors (i.e. large corporations, local merchants, farmers, etc.) providing reasons to support your organization either through donations or volunteering.
 - 6) Food4Kids and Halton Food For Thought rely on donations from partnering associations and private donations. What are other avenues these organizations can take to increase donations?



Please include the following with your submission:

- A. A referenced bibliography (where necessary).
- B. Two brief letters of reference (including current contact information for each reference).
- C. A current academic transcript from all secondary schools attended (photocopies of transcripts are sufficient and transcripts will not be returned).
- D. A photocopy of proof of acceptance to a post-secondary institution or trade school, which can be remitted when available.
- 2) You may enter one essay per topic if you choose, however, each applicant cannot be awarded more than one scholarship. Duplicate and incomplete submissions will not be considered. If you are submitting an essay for more than one topic, only one application is required. Application confirmations will not be sent out.
- 3) Group essay applications/submissions will not be accepted. Essay submissions must be made by an individual only.
- 4) All essays must be submitted in English.
- 5) It is the applicant's sole responsibility to ensure that there is no plagiarism or copyright infringement in the submitted essay(s). Plagiarized material will result in an automatic disqualification.
- 6) The scholarship awards are open to graduating high school students residing locally and registered with a secondary school within the Board's (OMDREB) jurisdiction, or whose parent is an active Member of OMDREB.
- 7) Essay submissions will be judged by an independent panel of judges. Video essays will be judged on content, not technical skills.
- 8) Applicant and secondary school names will be removed from all essay submissions that are presented to the panel of judges.
- 9) Scholarship award recipients will be contacted by May 26, 2017, concerning the status of their submission.

A scholarship of \$2,500 will be awarded to each award recipient at an awards presentation hosted by The Oakville Milton and District Real Estate Board in June 2016, at a location to be determined.

The decision of the panel of judges is final and is not subject to an appeal.

Please note that if any information provided by the applicant is determined by The Oakville, Milton and District Real Estate Board to be inaccurate or misleading, The Oakville, Milton and District Real Estate Board may cancel or revoke any grant, if awarded, in its sole discretion and the applicant will be required



to reimburse The Oakville, Milton and District Real Estate Board for the full amount of the grant, if paid.

All applications must be submitted by mail, in person, or electronically via fax or e-mail. **All applications must be submitted/received by 4:30 p.m. on May 8, 2017**. No late submissions will be considered.

- Ability to establish a coherent, convincing response to the topic
- Adherence to format and length rules
