Members will be given four (4) weeks in which to take this course. Failure to do so will result in a \$100.00 fine.

## SAFEACCESS<sup>™</sup> System for MLS

The SAFEACCESS<sup>™</sup> System login ID and Password is provided for the sole and exclusive use of the registered User and may not be shared with or used by any other individual. Every new Member joining the Board will be required to set up a SAFEACCESS<sup>™</sup> Password for access to Matrix. The cost for this set up is \$25.00. User I.D.s and Passwords are non-transferable.

The SAFEACCESS<sup>™</sup> platform has effective, automated methods for tracking and identifying shared logins as well as an automated remediation process to deal with accounts violating this policy. Failure to comply with this provision may result in the account being flagged and the matter being referred to the Professional Standards Committee for possible disciplinary action against the offending Member, which may include a maximum fine of \$10,000 and loss of Subscriber privileges.
